1. **Roll Call:** Robert Dazlich, Jacqueline Huston, Carol Weinhardt, Cadie DiGiambattista, Vinn Ferraro, Tyler Bonaventure, Kristen Cervantes, Jessica Hampel, DanaMarie Convery
2. **Approval of Minutes February 13, 2025-** Jacqueline Huston made a motion to approve the February 13, 2025 minutes, Carol Weinhardt seconded, minutes were approved.
3. **Discussion Items and Updates:**
  - a. **COST-** Transaction conference 3 days long April 15-17 at Harrah's in Atlantic City; 1200 plus guests, over 90 workshops, 135 exhibit tables and 9 vehicles on display.
  - b. **NVRA-** 1<sup>st</sup> quarter is completed for 2025; sent out 135 registration and opportunity forms mailed to the applicants
  - c. **Gloucester County Quarterly Report-** CSR information calls 560; information packets sent 105; 136 applications processed; a little blurb was put in the County Newsletter which gained a lot of attention from the seniors
  - d. **SJTA Quarterly Report-** CSR trips booked 1,313; scheduling calls 750; outgoing and return call 41; information calls 238
  - e. **ModivCare-** meeting was held on February 20, 2025, they would not confirm how many providers they have in the Gloucester County area. Next meeting is in June where Dana will ask the question again.
4. **CAC-** Robert thinks it's in Trenton this month
5. **Budget-** Tyler is working on the bids for vocation, veterans and ACT, will have that finished by today or tomorrow and send it out; Jessica is waiting on agreements for everything, she emailed Lisa Tulley back to see about the dates changing
6. **Regional Transit Report-** Jacqueline reported Pureland last meeting was March 28 they reported one-way passengers 2,362; total internal shuttle trips 943; for a grand total of 3,305; total trips were down 107 from prior month from January; from February 2024 to February 2025 up by 175 trips; TAMP (transit accessibility and mobility pilot program) agreement going to the Commissioner meeting on May 14 for signatures and approval

7. **NJ Transit Report-** 5311 paperwork was sent out, waiting for some SCDRTAP paperwork to go out; fiscal year 2020 5310 is \$100,000; Rodeo and the Transaction Conference is happening next week.
