On Wednesday February 9th, Director Frank DiMarco, Commissioner Denice DiCarlo, liaison to the Department of Veteran Affairs, and Surrogate Joe Chila presented Mr. James T. Ward with the Gloucester County Military Service Medal at a private ceremony at his home.

Mr. Ward is a 98 year old World War II veteran who volunteered to serve his country at the tender age of 19. He served as a German prison camp guard and company Bugler in multiple forts in California and Hawaii. He was stationed in Hawaii in 1945 when the United States was preparing the battleship USS Missouri for General Douglas MacArthur to accept the surrender of Japan to end the war.

Mr. Ward resides in the Oak Valley section of Deptford with his wife Patricia and he has six children along with 9 grandchildren and 2 great grandchildren. Mr. Ward is a member of the Greatest Generation of Americans. On behalf of the citizens of Gloucester County we thank Mr. Ward for his service to our country.

AFFORDABLE HOUSING GRANT FOR ADULTS WITH SPECIAL NEEDS APPROVED!

Director Frank J. DiMarco announces the Gloucester County Housing Development Corporation will receive an Affordable Housing Trust Fund grant of \$4,200,000.

This award will provide funds for the project known as Rowan College of South Jersey's Special Needs Rental Housing, which will consist of the new construction of a 24-unit rental project for individuals with special needs.

“ The Rowan College of South Jersey's Special Needs Rental Housing project will be developed on the campus of our county college. This project will allow our special needs community to reach a level of independence with their own apartment right around the corner from the services they need,”

Former Senate President Steve Sweeney has been a strong voice for the needs of our Special Needs Community throughout his career. The funding provided by the Affordable Housing Trust Fund grant would not have been possible without his advocacy in Trenton.

The Special Needs Rental Housing project will be constructed on the campus of Rowan College of South Jersey, 1400 Tanyard Rd. Sewell, close by the Rowan Integrated Special Needs Center (RISN).

MARCH IS TIRE AMNESTY MONTH!

The Gloucester County Board of Commissioners, in partnership with the Gloucester County Improvement Authority, has declared March 2022 as Tire Amnesty Month.

Gloucester County will accept used tires from county residents and municipalities at the Solid Waste Complex in South Harrison, March 1st to March 31st, Monday through Friday from 8:30 a.m. to 3 p.m. A special weekend drop-off will be held on Saturday, March 19th from 8 a.m. to 12 p.m.

"Discarded and forgotten tires can fill with standing water, creating a breeding ground for mosquitoes that can carry viruses such as the West Nile and Zika. By collecting tires from residents, we are able to properly discard them and prevent these diseases from being able to gain traction," said Director Frank J. DiMarco.

BOARD OF COMMISSIONERS SUPPORT SENATE BILL 1200

Director Frank J. DiMarco and the Gloucester County Board of Commissioners passed a Resolution in support of Senate Bill 1200.

This bill permits the Legislature to terminate certain declarations by the Governor for state of emergencies or public health emergencies and limits duration of such declarations unless Legis-

lature approves extension.

Commissioner Denice DiCarlo, liaison to the Department of Emergency Response, said, "We have seen how efficient emergencies can be handled when great leaders step up. This bill will give the people the opportunity to act on behalf of the residents they represent."

Director DiMarco says that in 2021, the county received 6,547 tires. To date, this Tire Program has taken over 260,045 tires out of the waste stream and recycled them.

Participation is completely free and is limited to Gloucester County residents only. Commercial Businesses are not permitted. At this time, nothing over a passenger pick-up truck tire size will be accepted. Tires may

be on or off the rim, but must be separated by type. There is a limit of 10 per residence.

The Gloucester County Solid Waste Complex is located at 493 Monroeville Rd. (Rte. 694), South Harrison Twp.

This Women's History Month, Gloucester County is honored to celebrate Commissioner Denice DiCarlo.

Commissioner Denice DiCarlo made history when she was appointed to the Gloucester County Board of Commissioners on February 2, 2022, making this the first time two women are serving on the Gloucester Board of Commissioners. Denice joins Deputy Director Simmons on the board, who also made history, by being the first woman to serve in a leadership role.

Commissioner DiCarlo now serves as the liaison to the Gloucester County Departments of Public Safety and Veterans Affairs including: Emergency Management, Emergency Management Council, Emergency Medical Services (EMS), Emergency Response, County Fire Marshal, Information Technology, Police Academy, Veterans Affairs, Veteran's Advisory Committee and Veteran's Cemetery Committee.

Commissioner DiCarlo is passionate about service and giving back to her community and has volunteered on numerous boards. As a resident of West Deptford in New Jersey, Commissioner DiCarlo first engaged with the community as a member of the West Deptford School Board and later the Township Committee. She served as the Mayor of West Deptford from 2015 to 2021, where she focused on stabilizing the tax rate and facilitating economic development.


