Preventing Elder Abuse

Vulnerable adults living in the community who are subjected to abuse, neglect, or exploitation and cannot fully protect or care for themselves can be serviced through Adult Protective Services. Services could include home care, meals on wheels, health care, legal intervention and case management to enable these vulnerable adults to live in a safe environment within the community. If you are aware of or suspect abuse of any kind, please call Gloucester County Adult Protective Services at (856) 256-2113 between 8am & 4pm, or dial 211 24 hours a day, 7 days a week. In cases of physical/sexual abuse and or medical/mental health crisis emergency, 911 should be called immediately.



What is Adult Protective Services?

Adult Protective Services (APS) programs have been established in each county in New Jersey to receive and investigate reports of suspected abuse, neglect and exploitation of vulnerable adults living in a community setting.

The Purpose of APS:

Stabilize a crisis situation using the least intrusive methods while respecting an individual's right to self-determination.

CONFIDENTIALITY

All records and communications pertaining to any report, evaluation or service provided pursuant to the Adult Protective Services Act (P.L. 1993, Ch. 249, C52:27D) are confidential.

APS is only permitted to share the results of an APS assessment when directed to do so by a court of competent jurisdiction or when disclosure of information is necessary for the Division or the APS provider to perform its responsibilities as set forth by statute.

Making a Referral to APS:

The referral should be made by the person with first-hand information about the client.

The referral should be made directly to the county in which the client resides.

The referral should consist of as much information as possible including:

- ✓ Client's name, address, phone number
- ✓ DOB and Social Security number
- ✓ Diagnoses – health and/or mental health issues
- ✓ Family members/support systems (services/agencies involved)
- ✓ A specific allegation of abuse, neglect or exploitation

APS CASES

APS may become involved in situations that meet all of these conditions:

A vulnerable adult is:

- ✓ Age 18 years or older, AND
- ✓ Residing in the community, AND
- ✓ Due to physical or mental illness, disability or deficiency, lacks sufficient understanding or capacity to make, communicate, or carry out decisions concerning his or her well-being, AND
- ✓ Is the subject of abuse, neglect or exploitation.

Low Cost Spay/Neuter Program

You may be eligible to have your pet spayed or neutered at a discounted price

There are many pet owners who want to spay or neuter their pets, but due to the costs involved, they may doubt their ability to do so. The good news is that there are many veterinarians and organizations who are ready and able to help. If you receive any of the following benefits, your dog or cat can be spayed or neutered for \$10: Food Stamps, Medicaid, General Public Assistance, Rental Assistance, Lifeline Utility Credit, Tenant's Lifeline Assistance, SSI, or PAAD. As a result of spaying and neutering, pet overpopulation can be prevented, and fewer animals will be left in shelters. Seasonal Flu Clinics

Annual flu shots are recommended by the Centers for Disease Control and Prevention for seniors. Residents of Gloucester County will be able to receive influenza vaccines free of charge at designated locations starting in the fall. Fluad Quadrivalent, an adjuvanted flu vaccine that helps create a stronger immune response to vaccination, will be available to those over age 65.
