





**RESOLUTION AUTHORIZING CONTRACTS WITH SAINT JOHN OF GOD COMMUNITY

**WHEREAS**, the County of Gloucester, a designated workforce investment area, pursuant to the Workforce Innovation and Opportunity Act (WIOA) along with guidelines created by the Work First New Jersey TANF Program has a need to provide Community Work Experience Program (CWEP) and Group Job Search (GJobs) classes; and

**BE IT FURTHER RESOLVED**, that a brief notice stating the nature, duration and contract amount, as well as a copy of this Resolution and the contract are on file and available for public inspection in the office of the Gloucester County Clerk of the Board of County Commissioners. The aforementioned notice shall be published once in the South Jersey Times pursuant to the requirements of NJ Local Public Contracts Law; and

**BE IT FURTHER RESOLVED**, before any purchase or services can be delivered pursuant to the within contract, a certification must be obtained from the Treasurer of the County of Gloucester certifying that sufficient funds are available at that time and identifying the line item of the County budget from which said funds will be paid.
