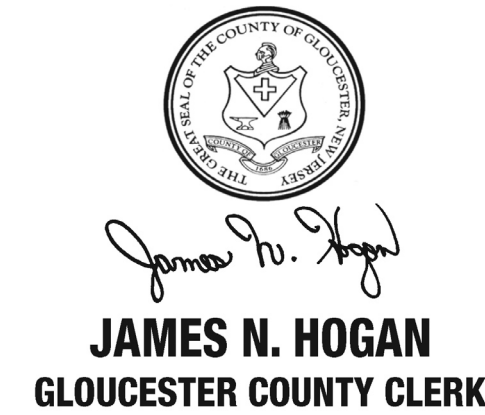

<p>The Board of Education of the Borough of Glassboro, in the County of Gloucester, New Jersey ("School District"), is authorized to: (a) undertake for lawful school purposes a capital improvement program consisting of: (i) various rehabilitation projects, additions and alterations at the <b>Dorothy Bullock Elementary School</b>, together with the completion of various other improvements, including improvements to security and communication systems, the addition of two (2) new rooms, roof maintenance, replacement of classroom ventilators, and related site work at the Dorothy Bullock Elementary School; (ii) various rehabilitation and renovation projects at the <b>Thomas E. Bowe Middle School</b>, together with the completion of various other improvements, including improvements to security and communication systems, replacement of the gym floor, bleachers, basketball backstops and scoreboard, installation of wall pads, roof and wall maintenance and repairs, and other related site work; (iii) various rehabilitation projects at the <b>J. Harvey Rodgers School</b>, together with the completion of various other improvements, including improvements to security and communication systems, roof replacement, underground pipe replacement, and other related site work at the J. Harvey Rodgers School; (iv) various rehabilitation projects and site improvements at the <b>Glassboro High School</b>, together with the completion of various other improvements, including refurbishing of the roof and bus canopy, upgrades to HVAC systems and the replacement of HVAC rooftop equipment, and other related site work at the Glassboro High School; (v) the replacement of the roof and related site work at the <b>Beach Administration Building</b>; and (vi) the completion of such other work and improvements, and acquisition of furniture, fixtures and equipment as may be necessary therefor or related to the completion of the projects set forth above; (b) expend for all the foregoing an amount not to exceed \$13,012,000 (\$10,882,000 of which represents eligible costs ("Final Eligible Costs"), as determined by the Commissioner of Education); and (c) issue bonds of the School District for said project in an amount not to exceed \$13,012,000 in which event the State will pay approximately 40% of the debt service (principal and interest) of the school bonds issued to finance the Final Eligible Costs; and (d) transfer unexpended bond proceeds between said school facility projects. This school facilities project includes \$2,130,000 for school facility construction elements in addition to the facility efficiency standards developed by the Commissioner of Education or that are not otherwise eligible for State support pursuant to <i>N.J.S.A. 18A:7G-5(g)</i>.</p>	<p>If Proposal I is approved by the voters, the School District is also authorized to: (a) undertake for lawful school purposes, a capital improvement program consisting of: (i) security upgrades at the <b>Dorothy Bullock Elementary School</b>, including, building-wide systems upgrades to the public address, clock and communication system, and other related site work; (ii) various security and site upgrades, and additions at the <b>J. Harvey Rodgers School</b>, together with the completion of various other improvements, including, construction of an addition to the school consisting of nine (9) classrooms and one (1) restroom, installation of a new public address system in the gym and cafeteria, construction of a new driveway and additional parking spaces, new flagpole, lighting and signage, and other related site work; (iii) various rehabilitation projects at the <b>Glassboro High School</b>, together with the completion of various other improvements, including security upgrades, stage acoustical improvements, HVAC noise reduction in auditorium, improvements to the auditorium stage, and other related site work at the Glassboro High School; (iv) improvements to the <b>Transportation/Operations Building</b>, including replacement of doors and related security improvements, and associated improvements necessary heretofore or related thereto; and (v) the completion of such other work and improvements, including the acquisition of fixtures and equipment as may be necessary therefor or related to the projects set forth above; (b) expend for all the foregoing an amount not to exceed \$9,834,000 (\$2,155,623 of which represents eligible costs ("Final Eligible Costs"), as determined by the Commissioner of Education); (c) issue bonds of the School District for said project in an amount not to exceed \$9,834,000, in which event the State will pay approximately 40% of the debt service (principal and interest) of the school bonds issued to finance the Final Eligible Costs; and (d) transfer unexpended bond proceeds between said school facility projects. This school facilities project includes \$7,678,377 for school facility construction elements in addition to the facility efficiency standards developed by the Commissioner of Education or that are not otherwise eligible for State support pursuant to <i>N.J.S.A. 18A:7G-5(g)</i>.</p>		<p>If Proposal I is approved by the voters, irrespective of whether Proposal II is approved by the voters, the School District is also authorized to: (a) undertake for lawful school purposes, a capital improvement program consisting of: (i) various renovations and site upgrades to <b>Glassboro High School</b>, together with the completion of various other improvements, including, the construction of new bathroom facilities and the completion of fielding and drainage improvements at the football stadium, the removal and replacement of certain exterior doors at Glassboro High School, and other related site work; and (ii) the completion of such other work and improvements, including the acquisition of fixtures and equipment as may be necessary therefor or related to the projects set forth above; (b) expend for all the foregoing an amount not to exceed \$1,650,000 (\$967,500 of which represents eligible costs ("Final Eligible Costs"), as determined by the Commissioner of Education); (c) issue bonds of the School District for said project in an amount not to exceed \$1,650,000, in which event the State will pay approximately 40% of the debt service (principal and interest) of the school bonds issued to finance the Final Eligible Costs; and (d) transfer unexpended bond proceeds between said school facility projects. This school facilities project includes \$662,500 for school facility construction elements in addition to the facility efficiency standards developed by the Commissioner of Education or that are not otherwise eligible for State support pursuant to <i>N.J.S.A. 18A:7G-5(g)</i>.</p>

EXPLANATORY STATEMENT

Voters are requested to cast a vote on each of the three (3) Proposals. If Proposal I is approved by the voters, the School District will be authorized to undertake the projects set forth therein.

If Proposal II is approved by the voters, irrespective of the outcome of Proposal III, the School District will be authorized to undertake the project set forth therein only if the voters of the School District also approve Proposal I. If the voters of the School District approve Proposal II, but do not approve Proposal I, the School District will not be authorized to undertake the projects set forth in Proposal II.

If Proposal III is approved by the voters, irrespective of the outcome of Proposal II, the School District will be authorized to undertake the project set forth therein only if the voters of the School District also approve Proposal I. If the voters of the School District approve Proposal III, but do not approve Proposal I, the School District will not be authorized to undertake the projects set forth in Proposal III.

If Proposal I is approved by the voters of the School District, the School District will be authorized to expend an amount not to exceed \$13,012,000 for the projects described in Proposal I (of which \$10,882,000 represents Total Final Eligible Costs) and to finance the costs thereof by a school bond issuance in a principal amount not to exceed \$13,012,000, of which the State of New Jersey will pay approximately 40% of the debt service (principal and interest) allocable to the Total Final Eligible Costs. The total project costs in Proposal I include \$2,130,000 for school facility construction elements in addition to the facilities efficiency standards developed by the Commissioner of Education, or that are not otherwise eligible for State support pursuant to *N.J.S.A. 18A:7G-5(g)*.

If Proposals I and II are approved by the voters of the School District, the School District will be authorized to expend an amount not to exceed \$22,846,000 for the projects described in Proposals I and II (of which \$13,037,623 represents Total Final Eligible Costs) and to finance the costs thereof by a school bond issuance in a principal amount not to exceed \$22,846,000, of which the State of New Jersey will pay approximately 40% of the debt service (principal and interest) allocable to the Total Final Eligible Costs. The total project costs in Proposals I and II include \$9,808,377 for school facility construction elements in addition to the facilities efficiency standards developed by the Commissioner of Education, or that are not otherwise eligible for State support pursuant to *N.J.S.A. 18A:7G-5(g)*.

If Proposals I and III are approved by the voters of the School District, the School District will be authorized to expend an amount not to exceed \$14,662,000 for the projects described in Proposals I and III (of which \$11,849,500 represents Total Final Eligible Costs) and to finance the costs thereof by a school bond issuance in a principal amount not to exceed \$14,662,000, of which the State of New Jersey will pay approximately 40% of the debt service (principal and interest) allocable to the Total Final Eligible Costs. The total project costs in Proposals I and III include \$2,812,500 for school facility construction elements in addition to the facilities efficiency standards developed by the Commissioner of Education, or that are not otherwise eligible for State support pursuant to *N.J.S.A. 18A:7G-5(g)*.

If Proposals I, II and III are approved by the voters of the School District, the School District will be authorized to expend an amount not to exceed \$24,496,000 for the projects described in Proposals I, II and III (of which \$14,005,123 represents Total Final Eligible Costs) and to finance the costs thereof by a school bond issuance in a principal amount not to exceed \$24,496,000, of which the State of New Jersey will pay approximately 40% of the debt service (principal and interest) allocable to the Total Final Eligible Costs. The total project costs in Proposals I, II and III include \$10,490,877 for school facility construction elements in addition to the facilities efficiency standards developed by the Commissioner of Education, or that are not otherwise eligible for State support pursuant to *N.J.S.A. 18A:7G-5(g)*.
