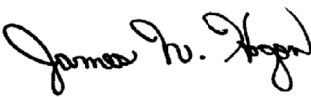
VOTERS! ATTENTION!

Registered voters may choose to vote early at any one of the locations listed below or vote on Election Day at their designated polling location.

1. To vote for a candidate, touch the person's name.
2. To vote for someone not on the ballot, touch Write-in.
3. To Vote for a Public Question (if applicable) touch the 'Yes' or 'No'.
4. When you finish making your selection, touch **'Cast your Ballot'**. Stay at the booth until you see the Thank You Screen.
5. To change the screen display or language, touch the buttons in the upper right corner of the screen.
