PUBLIC QUESTION TO BE VOTED UPON

TOWNSHIP OF WEST DEPTFORD PUBLIC QUESTION

Shall the Township Committee of the Township of West Deptford adopt an ordinance eliminating the Township's Planning Board and the Zoning Board of Adjustment and create a single Land Use Board to have all powers and duties as granted by the Municipal Land Use Law, N.J.S.A. 40:55D-1, et seq.?

Interpretative Statement

The proposed ordinance would amend Chapter 102 of the Code of the Township of West Deptford titled "Land Use Procedures" to eliminate Articles I, II, III, IV, V and VI and enact new article to establish a single Land Use Board.

The Land Use Board would consist of the Mayor or the Mayor's designee in the absence of the Mayor (Class 1); one of the officials of the municipality other than a member of the Governing Body to be appointed by the Mayor (Class II); a member of the Governing Body to be appointed by it (Class III); and six (6) other citizens of the municipality to be appointed by the Mayor (Class IV). There would further be appointed up to four (4) alternate members to be appointed by the Mayor.

The Land Use Board would have and exercise all powers, duties and procedures as set forth by the Municipal Land Use Law, N.J.S.A. 40:55D-1, et seq. for Planning Boards and Zoning Boards of Adjustment.

A yes vote on the above question means that you want the Township to amend its Code to eliminate the Planning Board and the Zoning Board of Adjustment and combine the powers and duties of such boards in a single Land Use Board.
