<p>Interpretative Statement</p> <p>The proposed ordinance would amend Chapter 102 of the Code of the Township of West Deptford titled "Land Use Procedures" to eliminate Articles I, II, III, IV, V and VI and enact new article to establish a single Land Use Board.</p> <p>The Land Use Board would consist of the Mayor or the Mayor's designee in the absence of the Mayor (Class 1); one of the officials of the municipality other than a member of the Governing Body to be appointed by the Mayor (Class II); a member of the Governing Body to be appointed by it (Class III); and six (6) other citizens of the municipality to be appointed by the Mayor (Class IV).
