2026 Body Art and Ear-Piercing Facility Annual Permit Renewal

December 31st 2025

Dear Body Art Operator:

N.J.A.C. 8:27-2.4 and 9.2, Body Art and Ear-Piercing Facility Standards Approval to Operate requires that permits to operate a body art and ear-piercing establishment is renewed annually. Once the application, supporting documents and fee are received and approved, your 2026 Permit will be issued. To renew your permit, please submit the following by February 16th 2026. Please be advised that failure to renew your permit could result in the temporary suspension of your business:

- ✓ Annual Permit Renewal Fee of \$250.00 (pay online).
- ✓ Completed "Application for Approval to Operate a Body Art Establishment". (Forms can be found at: gloucestercountynj.gov)
 - Please ensure you list each current practitioner and their specialty. If you have more than six, please include an additional page.
- ✓ Current proof of professional liability insurance for each practitioner.
- ✓ Medical waste Generator number -- verification that you are current with the NJDEP under N.J.A.C. 7:23-3A et seq.
- ✓ Any change (if applicable) in information regarding your business: equipment, instruments, inks, jewelry, procedures, personnel, ownership, client applications, policies, etc.

Additional Notes:

- Current Blood Borne Pathogen Certification for each practitioner and apprentice is to be kept on file at your facility and available for all inspections.
- The credentials of all new practitioners must be reviewed by this office prior to an artist beginning work at your establishment. A separate application and documents would need to be submitted online.
