

RESOLUTION AUTHORIZING A CONTRACT WITH BUILDED CORPORATION, IN AN AMOUNT NOT TO EXCEED \$89,980.00

WHEREAS, the County of Gloucester requires the services of a qualified provider that will implement a virtual and in person entrepreneurship/career mentoring program for the Workforce Innovation Opportunity Act (WIOA) for Adult, Dislocated and Youth as well as the Work First New Jersey (WFNJ) populations; and

WHEREAS, the County requested proposals via RFP# 22-049 from interested providers and evaluated those proposals consistent with the New Jersey Local Public Contracting Law and the County's fair and open procurement process; and

WHEREAS, the evaluation, based on the established criteria, concluded that BuildEd Corp with offices at 650 Sentry Park, Blue Bell, PA, 19422, made the most advantageous proposal; and

WHEREAS, the contract shall be for estimated units of service for an amount not to exceed \$89,980 from August 17, 2022 to June 30, 2023, pursuant to the proposal submitted by BuildEd Corp; and

WHEREAS, the Certificate of Availability of Funds has not been issued at this time as this is an open ended contract, which does not obligate the County of Gloucester to make any purchase, and prior to any purchase being made or service rendered pursuant to the within award, a Certificate of Availability shall be obtained from the Treasurer of the County of Gloucester certifying that sufficient monies are available at that time for that particular purpose and identifying the line item of the County budget from which said funds will be paid; and

WHEREAS, this contract may be awarded pursuant to the provisions of N.J.S.A. 40A:11-5(1)(a)(i) et seq., in that the subject matter of the contract is for the provision of professional services.

NOW, THEREFORE, BE IT RESOLVED, by the Board of Commissioners of the County of Gloucester that the Director of the Board be and is hereby authorized to execute and the Clerk of the Board be and is hereby authorized to attest to the contract with BuildEd Corp. for the provision of an Entrepreneurship/Career Mentoring for WIOA and WFNJ participants for an amount not to exceed \$89,980.00, from August 17, 2022 to June 30, 2023; and

BE IT FURTHER RESOLVED, that a brief notice stating the nature, duration, service and amount of the contract, if applicable, and a copy of this Resolution and the contract are on file and available for public inspection in the Office of the Clerk of the Board of Gloucester County. The aforementioned notice shall be published once in the South Jersey Times pursuant to the requirements of the Local Public Contracts Law.
